Elimination of WMATA 3rd Party Allocations for TRANServe Federal Agencies

Effective for the January 2013 benefit month, there will be no access to 3rd party passenger allocations. TRANServe participants will no longer be able to allocate the transit benefit to 3rd party vendors via the Washington Metropolitan Area Transit Authority (WMATA) SmartBenefits® Program. Note: The use of SmartBenefits® on Metrobus, Metrorail and local bus systems using the SmarTrip® card are excluded.

Guidance on Credit Card Processing

If you are currently using SMARTBENEFITs, it will not be long before you will be switching to a credit card. Please note this change is not affecting all agencies the same way. The change only affects agencies that use the Department of Transportation (DOT) as their program administrator. It is DOT that is moving to the TRANServe credit card and only riders whose transportation subsidy is being processed by DOT/TRANSERVE are being impacted by it.

Please find out from your agency when and if this change is becoming effective for you and follow the guidelines below.

When you first receive the card, it must be activated. This will allow your payment to be processed. The credit card form must be sent each month, with a current date on the form. K&K does not store data, and the system is not set up for automatic payment.

When filling out the information, please print legibly. This is most important because if inaccurate information is entered, it will slow down the process and may delay the processing of your funds. In addition, if credit card information is not processed on time, the government will remove funds. When writing your credit card number on the form, it will be very helpful if the numbers were written in groups of four (i.e., 1212 3434 5656). This will help in accurately reading card numbers.

In an effort to timely process your payment, K&K needs a two-day window from the time your agency informs you of the cut-off date before they remove the funds. The cut-off date is the 9th of each month. Therefore, if you do not receive an invoice by email in two days notifying you that your form has been received (especially if you are getting close to your cut off time), please call or email Keith Trent. K&K has put in place checks and balances for this process. The payment receipt is generated from K&K's credit card company.

Tougher Rules in Virginia Regarding Texting While Driving

Support is building in Virginia for tougher rules against drivers who text while at the wheel.

This month a bill was introduced that proposes to make texting while driving a primary offense. This means an officer can pull you over if you are spotted operating a hand-held device on the road.



This bill will not only include texting but emailing and similar activities. Driving will doing these activities will be considered "reckless driving," a Class 1 misdemeanor that could result in up to one year in prison, a \$2,500 fine or both.
